**The effect of the Order:** To introduce 'No Waiting At Any Time' restrictions on Milwards, on its south side, from its junction with Paringdon Road to a point about 20 metres east of that junction and on its north side, from its junction with Paringdon Road to a point on the east side of its northern arm leading to Nos. 1 to 5, opposite Nos. 4 and 5, in the district of Harlow.

This Order will be incorporated into The Essex County Council (Harlow District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by replacing tile numbers (TL435 077 revision 0 replaced with revision 1).


