

Dear Richard,

I would like to comment on the proposed parking restriction scheme around the Brook Road /Crossing Road/ Allnutts Road areas of Epping.

As a resident of Crossing Road, I am pleased to see that there will be space for local residents to park, and fully support the proposed resident permit scheme.

However, on the notification letter we have received, I am concerned to see that the residents of Crossing Road do not appear to be eligible to apply for resident permits.

Section 2 concludes with "All properties with a Brook Road, Allnutts Road, The Hedgerows, Charles Street, Warren Field postal addresses will be able to apply for a maximum of 2 parking permits and unlimited visitor permits".

The Hedgerows is a gated development, to which vehicle access is restricted. Will the residents of The Hedgerows still be required to apply for parking permits, even though the road has not been identified within the parking restriction proposal?

Furthermore, the residents of Crossing Road, which is listed within the proposal, are not listed as being eligible for resident parking permits.

Can you please clarify this matter for me.

I am writing to object to the introduction permit holder only parking in Allnutts Road, Charles Street, Brook Road and Crossing Road, Epping Essex.

The parking 'problem' in these roads is caused in large part by commuters from other parts of Essex driving to Essex driving to Essex driving nuisance. A space can usually be found by residents, albeit involving a short walk back to the house.

The problem itself has been caused by those responsible for coordinating parking and travel in Essex to (a) provide adequate parking at the station for commuters (and there are suggestions that this will be made dramatically worse by building houses on the said car park) and (b) the piecemeal imposition of parking restrictions in the roads closest to the station that displaced the commuters into roads further away. We were impacted the very next day after the Orchards had been yellow lined to prevent day parking.

I do not see how permit parking is going to resolve the underlying problem of a lack of parking for central line commuters and predict the commuters will simply park further out along roads that are not yet restricted and in some case are neither suitable nor safe for on street parking.

I know that at a recent parish council meeting in Morton, a village outside Harlow, concerns were raised about this scheme by people who currently park in to Epping to use the trains and the clerk informed the meeting that there were plans to build a multi-storey car park to accommodate commuters. As an Epping resident I have to say I have never seen or heard of any such plans. I would also consider that the parking authority has a duty to take into account the needs of commuters as well as Epping residents, all of whom are Essex residents and strike some sort of balance between the two.

I also find it quite shocking that TFL appear to have so little interest in promoting parking at the outlying underground stations as part of an integrated strategy to keep cars out of central London.

Aside from the objection to the principle of introducing schemes that attempt to solve a problem merely by displacing it into even more unsuitable and potentially dangerous locations, I also think the scheme itself has been untaken with little consultation or research.

For instance there is a playgroup in Allnutts Road where infants are dropped off at 9.30 and collected at 12.30 every weekday. What steps have been taken to ensure that parents of these children can drop off their children without harassment from parking wardens?

Crossing Road only has a couple of houses in it, all of which have driveways and therefore are largely unaffected by the commuters.

One side of Brook Road is unpaved hedgerow with a couple of pull-ins not shown on the map that hold about 4 cars each. I do not believe they are part of the highway and the road is not wide enough to allow parking down both sides in any event so how is that to be marked up?

I would like to know the anticipated cost of the permits and visitors' tickets and whether they are likely to rise every year or with the number of cars/books.

Even if the scheme goes ahead I would have thought a restriction of between 10 and 12 rather than 10 and 2.30 would be more than adequate to achieve its purpose without making life harder for the residents and the play group users.

Dear Sirs,

I refer to your proposed residents permit parking scheme for Warren Field CM16 7BA where I am a resident.

Although not a fan of resident permits I accept that parking in our area is a major problem - a lot of this is due to commuters parking their cars in our cul-d-sac which causes problems to some residents who may have insufficient parking on their own drive and need to park 'out on the road'.

However the major problem with you proposal is that the entry road into Warren Field is far too narrow to allow parking on both sides of the road. For the past 15 years or so Police cones have been placed on the east side of the road to prevent cars parking on that side. On numerous occasions, the last being I believe on Tuesday 21st, the Refuse collection lorry could not gain access to the bins in the cul-d-sac because a commuter had moved a cone and parked on that side. This could also affect the Fire Brigade or Ambulance services from gaining access etc. which, should this happen, may have severe consequences. I understand residents have rung your department to come down and view the scenario but without success.

We would be grateful if a review of this situation could be carried out as soon as possible - definitely before the new scheme becomes set in stone.

There will be significant negative impact if non-residents are allowed permits as there is already a scarcity of parking spaces for

Many residents on Allnutts road do not have driveways and therefore are limited to only 2 permit based car parking spaces.

The majority if not all Bower hill property's have a number of driveway parking spaces but some who choose to use their space The majority it not an Dower am property's nave a number of driveway parking spaces but some who choose to use their space for parking spaces or unused vehicles as well as using their spaces for the sale of vehicles, and then unnecessarily using additional parking spaces on Allmutts road.

There has been a previous case where an entire end of Allnutts Road was parked with vehicles for sale.

Hence, I feel it is important that what parking spaces are available and the restrictions should only be for the residents of the rience, I recent is important that what parking spaces are available and the restrictions should only be for the residents of concerning streets proposed to make the scheme sound and in the best interest of residents that actually live on the street.

Allowing one non-resident to park will set a precedence for others to follow. Yours faithfully,

I am responding to the notice proposing the introduction of Permit Holders Only Mon-Fri 10am-2.30pm (Zone EF1) in Allnutts Road, Brook Road, Crossing Road, Charles Street and Warrenfield. I write as county and district councillor for this area.

I OBJECT to the omission of business permits from the proposal. These are required in order to
provide parking for staff at Allnutts Stores (and potentially staff at the nursery operating out of
Allnutts Institute) who will otherwise have no-where in the vicinity to park. This could threaten the
viability of the store which is the only shop in Epping on this side of the railway line and therefore
an important community facility.

The provision of business permits could be tightly restricted to particular premises or in number in

order to prevent abuse. This is a minor amendment which I hope can be incorporated without affecting the overall scheme.

- I OBJECT to parking being allowed on both side of the entrance road to Warrenfield. This road is too narrow to allow parking on both sides of the road. For the past 15 years or so Police cones have been placed on the east side of the road to prevent cars parking on that side. In the absence of cones refuse lorries and similar vehicles have been unable to gain access to the cul-de-sac. I would support permit parking on one side of the road and restrictions probably no waiting at any time on the other side. This is a minor amendment which I hope can be incorporated without affecting the overall scheme.
- I SUPPORT the overall concept of the scheme including the 10am-2.30 pm hours and especially in Allnutts Road, Brook Road, Crossing Road and Warrenfield. The position in Charles Street is more balanced but it seems logical to include it as part of the scheme.
- 1 SUPPORT the introduction of no waiting at any time on the inside corner of Charles Street adjacent to no.36 in order to improve visibility and safety.

#### Other issues:


- The no waiting at any time opposite the entrance to Warrenfield outside 9-11 Charles Street (junction protection) appears to be longer than necessary for the purpose. Reducing the length to the minimum necessary should be considered.
- I have previously raised the suggestion of limited waiting restrictions outside Allnutts Stores, so shoppers can park and use the business between 10 and 2.30pm. I gather this is difficult to achieve but remain concerned about this as the new restrictions could limit trade. I understand the 10 minute observation period required of enforcement officers will in practice mean shoppers will be able to pop into the shop for short visits without getting a ticket. I trust this will be the case.

You have received emails tonight in response to a letter I distributed to residents this evening. The letter did not advocate a Support or Oppose position but encouraged residents to make their views known. I am happy to send you a PDF of the letter if you wish. The low number of objections received in response to the partnership's publicity (which only solicited objections, in line with usual practice) suggests that there is general acceptance of and support for the scheme.

Thank you for your work on this scheme, which hopefully will bring relief to residents who have been fighting for measures in this areas for over ten years.

I have spoken to a number of neighbours in Allnutts Road (Nos 43,50,60) all of whom were unaware of this. No letters have been received and there are no notices on lamp-posts. How were we supposed to know we had to go looking on lamp-posts for these important details anyway? Surely in this day and age important information like this should be emailed and followed up with paper communication. I am not surprised only 15 responses have been received from 220 households. It would appear most of us were not given the opportunity to respond!

From what little I can see from the information I have managed to get this morning, residents only parking Mon-Fri 10-2.30 seems reasonable. But at what cost are the permits? I have concerns for Allnutts Playschool on Allnutts Rd. Parents and carers drop children off at 9.15 (that is fine with the restrictions) and collect again at 12.15 (which means they cannot park). Allnutt's stores customers will also face difficulties parking 10-2.30 Mon-Fri. Very happy to see the addition of double yellow lines on the corner of Charles St and at the junction with Brook Road and Crossing

Good afternoon,



I would like to lodge a formal objection with regards to the planned parking changes in Charles Street, Epping, where I live. Please see below the reasons for my objection.

- From the letter received I could not ascertain the full impact on my situation in terms of impact, costs and inconvenience. If this change in any way affects my ability to park in the drive in front of my own property, or allows people to park in front of my house, blocking me in, that would be completely unacceptable.
- The map did not clearly indicate where parking bays would be, I would suggest a much more detailed map to avoid confusion, showing where every parking bay

- Various service providers use the parking in front of my house to drop off groceries, park during house renovations and collect my dog, it is important for me to be sure there would be no impact on this.
- · Although the situation with regard to streets crowded with cars on both sides is not ideal, there are many people who rely on being able to park here, and I don't know if any provision will be made to supply parking elsewhere.

As a resident of Charles Street, Epping, CM16 7AX, I would like to object to the proposed orders to introduce 'Permit Holders Only' and 'Pay & Display' parking bays in our street for a number of reasons:

- 1.) Exact details about how it would affect our parking is unclear and very confusing.
- 2.) One of the main reasons we bought our house was because of its dropped kerb and the free, easily accessible off-road parking on our drive.
- 3.) I have major concerns about how this would affect us as residents. Currently, we have no problems with parking, as we park on our drive and any of our visitors can park behind us if need be. Neighbours respect each other's driveways and nobody ever blocks our driveway. So I don't understand why there is any need to change how this works now.
- 4.) Both my husband and I work full-time, so we have dog walkers stopping by a few times every day to collect and drop back our dog for walks. Access to free parking in front of our house is absolutely vital. And it would be a time-consuming hassle for them to have to fiddle with visitor's parking cards on a daily basis.
- 5.) I am unsure: Would a parking bay be issued in front of our dropped kerb driveway? And would the issuing of resident parking permits then mean that other residents of Charles Street, with their own resident permits, could park in a bay that was usually reserved for us, in front of our house, and block our driveway?
- 6.) Having to apply for resident parking permits sounds cumbersome and time-consuming. And it would mean we would have to pay a fee for something that has always been free. Seeing that parking is free for us at the moment and we have no paperwork to fill out, applying and paying for resident parking permits does not sound at all appealing.
- 7.) I definitely do not want any pay & display bays. If the objective of this scheme were to protect the parking spaces of current residents from commuters into London, it might be understandable. But this just seems like a money-making scheme though, where residents will be forced to pay for parking which was always free

- 8.) We often have groceries delivered to our address from Tesco and would not be able to apply for visitor's permits for every possible Tesco van delivering groceries to our property. The same applies to any other orders and especially to our Amazon product orders which we receive on a regular basis. This would unnecessarily complicate things.
- 9.) We have refurbishment projects that we are planning to do over the next couple of years. It would be enormously complicated and challenging if tradesmen would not just be able to park on the kerb behind our car parked on the driveway, as they would need quick, free and easy access to our house when carrying out works at our property.

I wish to object to the proposed Order. My understanding of the Order is that there will be "No Waiting At Any time" outside my house. My objection is that I have lived at No. Charles Street, Epping for over years. I have always had a front garden and have always parked my car in the road outside my house or

I do understand that I can apply for a permit but this will not help when I have heavy shopping, a disabled friend visiting or arriving home late at night when I may have to park in another street. It is a frightening

My only alternative appears to be having my front garden paved over for a parking bay and applying for a dropped kerb, the cost of which, I imagine, will be thousands of pounds. Neither will it be good for the

As I mentioned in my letter 22 June 2009, the minute number of proposed Permit Holder Bays will be insufficient. I would suggest Residents Parking Bays outside of their own homes if it is absolutely essential

I would suggest more car parking space in the Epping area is required rather than more flats/houses.



Whilst we agree it is a pain to have station parkers in the street, surely the most sensible decision would be to yellow line the whole street and make it restricted parking for an hour or two during the week? In doing so, the homes that are more affected by the parking (Brook Road, Allnutts Road and parts of Charles St) would not have to worry about the station parkers and none of us would have to pay for the privilege of parking

It is obvious that the council is trying get more money out of residents by trying to impose Parking Permits when a single yellow line with time restrictions would achieve the same effect but without the extra cost for us! Why is it OK for yellow lines in The Orchards and Kendal Avenue (which work perfectly well) but not for those of us

We feel it is outrageous that after paying road tax and council tax, that EFDC want to make our street Permit Parking when there is no reason why this would be a better option than a single yellow line

I would like to know what research has been done to see what residents want and who exactly come up with this

Also why has the council decided to go for Permit Parking rather than yellow lines without getting the views of the residents, this is just an extra tax they wish to impose upon us and it is not acceptable.

Why should we, at our end of Charles St be penalised for the lack of parking around the other end of Charles St and Allnutts? The residents who live at 2-10 Charles St (our side of the street) have never expressed a desire for this scheme and we are angry that this proposal is being put forward. Paying for a permit won't guarantee a space and there will be fewer spaces available as they will be marked bays, so who exactly is benefitting from this? Just the council and their "stealth" tax in the guise of Parking Permits!

I trust that you will take our views against this proposal seriously and if you have to impose some sort of parking restrictions, that you come to the correct conclusion that the best option for Charles St is to implement a single

#### Dear Shane

RE the permit parking order for Charles St and the surrounding roads, in the part which lists the roads where parking permits can be applied for The Hedgerows is named but not Crossing Road. The Hedgerows is a group of new houses at the top of Crossing Rd which is not being included in the permit parking scheme because it is gated. The Hedgerows needs to be deleted and Crossing Road included. This will be facilitated before any changes are made to the public highway.

Why are the hours for permit parking 10-2.30 and not 10-4 as in most parts of Epping? We have devised the scheme to cater for local schools and the requirement to allow an element of short term parent parking. without the requirement of permits and this is based on previously advertised schemes and objections received which have led to changes being made to the original proposals.

In Allnutts Rd there is a small shop, formerly the post office, which provides an important service. What provision is being made for their needs? Visitors to the business would have a 10 minute grace period. Providing time limited bays for a short section of the road would have led to increased costs for the scheme and the requirement of additional signs/bay markings when these are not necessarily required with the grace



When will the informal consultation with residents start? The formal consultation commenced on 9 March and will terminate on 31 March.

Hi

We have had a notice attached to lamp posts about residents only parking but have not received a letter about it which apparently we should have done.

Is it possible to have the public consultation period extended if the letter was not posted to a large percentage of the people it should be posted to?



To whom it may concern,

I am really disappointed to live on Allnutts Rd and not have received any information on the residents parking consultation. Parking is a nightmare during the working week as people park here to access the underground from Epping Station and I fully support the proposal for permit parking. When there is a tube strike it is remarkable how few cars are parked on the street compared to most working days.

I am currently on maternity leave with a young baby, and yet if I go out in my car I often struggle to find parking anywhere near my house, if at all. Whilst heavily pregnant I went food shopping and was unable to find parking close to my house when I returned. I parked on the double yellow lines outside my house to carry in my bags and when I returned to move my car about 20minutes later I had received a £35 fine. This was really disappointing especially considering there were no other viable options at the time for myself at 8 1/2 months pregnant.

Many people on my street were under the impression that we only needed to respond to the petition with objections, not to respond with support. I really hope that these proposals for permit parking go ahead.
