I wanted your technical team to confirm, and they could not. The advisor suggested that a manger of the team would call me back to explain. THIS NEVER HAPPENED !! Instead on the 31st March a note was put through everyones door from commenting on why nobody had enquired......Well.... No wonder it was all originally worded in such a way that nobody really understood what was going on. Why wasn't there a letter sent to homeowners individually explaining how this sceme would effect Lets face it everyone is interested in how it effects their property at the end of the day !!!! According to note it seems if you have a residents permit you can park in your road during the hours of 10-am to 2-30pm, as there will be NO marked bays. My elderly retired neighbours despite some still think that they may not be able to park Please can a letter from the council be distributed to each individual home owner explaining how this scheme effects them...as it really is STILL really very unclear. Fancy sending a note to all on the 31st March the deadline date attempting to

make things more clear.

Dear Sirs

I would like to begin by saying the reason we haven't responded before to the proposal for parking restrictions in our street is because we thought after SO many years these latest proposals were AT LAST a done deal. Possibly other people thought the same, hence the poor response. It was only because we received a letter from our local councillor, that we realised it was not. Therefore, please see our response below.

We live at Charles Street and do not have a drive in front of our house. Therefore, we have been plagued for many years by commuters parking outside our house and even people parking for up to two weeks because they've caught the tube to go on holiday!

Not only is it extremely inconvenient and irritating to hardly ever be able to park outside your own house, but there are other factors involved too:

- Commuters arrive anytime from 5am onwards (unwilling to pay the fee for the station car park) many have excessively loud music blaring from their cars even as early as 7am.
- Then there is the fact that most of them slam their doors before leaving their cars and walking to the station. Sometimes they forget something so return to their car and slam the door for a second time! Those that travel in groups often talk loudly bordering on shouting.
- They also park very haphazrdly, especially the Smart cars that park up on the pavement bonnet or boot first. Many kerbs in Charles Street are damaged due to the way people are parking.



- Commuters are not considerate of people's drives either. They often park up to 3 or 4 feet over the dropped curb which is dangerous because people reversing out of their drives cannot always see
- There are people who work shifts as firemen and nurses coming home from a night shift, getting to bed to try to get to sleep only to be constantly disturbed by the arriving commuters over the rush hour period.

As far as the proposal is concerned, we have the following comments:

- The proposed time of 10am to 2.30pm should be increased to 10am to 4pm. This particular time period has been very effective in a neighbouring road in Epping Bower Vale.
- AT LAST double yellow lines are proposed for the bend around Charles Street (adjacent to no.38). This corner is extremely dangerous. However, there should be double yellow lines on the opposite side too thererby making that corner completely free of cars both sides.
- Could you also consider placing concrete bollards where the double yellow lines will be because people have been known to park entirely on the pavement to avoid being on the double yellow lines! Pedestrians then have no choice but to walk in the road!
- Letters should be sent to residents living the length of the double yellow lines emphasising these cannot be parked on at any time. ie. 24 hours a day 7 days a week.
- The double yellow lines at the junction of Crossing Road and Brook Road the ones actually in Brook Road need to be extended as even with the present retrictions it is a complete blind spot when pulling out from Crossing Road into Brook Road.

We also have a huge concern regarding who will police the restrictions once they are (hopefully) brought in! This concern comes from the fact that in Allnutts Road there is a community hall which every morning has pre-school events and near to finishing time parents begin to arrive and the road is chaos. They park on the double yellow lines that already exist in Charles Street and Allnutts Road, park up the curbs, on the bends often in huge Four by Fours making it extremely difficult to drive safely in that area and pedestrians too. Knowing this happens every day of the week like clockwork, always at the same time and lasts around 30 minutes, no traffic enforcement officer or vehicle have ever come to deal with the matter.

Also, on the double yellow lines across no. Charles Street, commuters often take a chance and park with the back wheels of their car over the lines. This is NEVER policed and they have only received tickets when residents have phoned to complain and even then only if a traffic enforcement officer is in the area.

Whilst writing can we also mention that when crews come to paint the new double yellow lines, can they please renew the old double yellow lines and the white lines across people's drives and the few disabled bays that exist in these roads. This is important because a couple of years ago the lines in Warren Field had faded and were broken in parts. A 'clever' commuter had found out that if the lines are not solid you can park on them without penalty! He went as far as taking a photo every day when he parked to prove the line this. Imagine the revenue lost whilst this went on!!



As residents living in Allnutts Road, Epping, Essex, we are writing to express our <u>support</u> for your proposal to introduce Permit Holders Only Mon-Fri 10am-2.30pm (Zone EF1) on Allnutts Road in the District of Epping Forest. (Permitted Parking Area and Special Parking Area, Amendment No.9 Order 201x, Section 2 (Zone EF1) that includes Allnutts Road.

This parking restriction is much needed and long awaited in order to eliminate the problem of commuter parking, Please introduce it as soon as possible.

# The Parking Problems in Allnutts Road

Commuters and visitors travelling into London drive to Epping to use the Central Line Underground Railway that terminates here. The car park at Epping Underground station has insufficient spaces for the required demand and according to the car park attendant is full by 8am most days. As commuters can park for free on local unrestricted roads they arrive very early to ensure they can get a parking space and save the now £6.40 all day weekday parking fee at the station car park.

Commuters currently park their vehicles (Cars, Vans & sometimes Trucks) in Allnutts Road from as early as 5am to catch the first train (5:10am) returning either between 3 to 4pm or after 7:30pm in order to get off-peak tube fares for travel before 6am, 9:30am-4pm and again after 7pm. These commuters disturb residents by slamming car doors very early in the morning and annoy them by parking vehicles inappropriately. They park their vehicles immediately adjacent to dropped kerbs, opposite vehicles parked fully on the other side of the road, preventing resident's vehicles from turning in and out of their driveways. Vehicles are parked either too far on the pavement preventing pedestrians from walking passed or so little on the pavement that large vehicles (delivery & refuse collection trucks) cannot get passed, their drivers then disturb residents further to enquire to whom the vehicles belong and if they

The parking problem along Allnutts Road has increased greatly in recent years with Traffic Regulation Orders being implemented on other local roads surrounding the station but not Allnutts Road. The road is also affected by the 1 hour No Parking 10-11am restriction on adjacent roads of Bower Hill and The Orchards, which mean residents and their visitors have park elsewhere during that time. The Epping parking review consultation conducted by EFDC in June 2009 proposed residents parking bays only on one side of the Allnutts Road insufficient for residents of the houses on both sides of the road between the Allnutts Institute and the railway line that have no off-street parking, so those residents objected and therefore no parking restrictions were introduced to the rest of the road. Please ensure that some parking restrictions do get implemented this time in Allnutts Road from the junction with Bower Hill to at least the Allnutts Cul-de-sac junction if not the Allnutts Institute, even if residents of the other end of Allnutts Road or other roads now added to the proposed scheme (Crossing Road, Charles Street, Brook Road and Warren Field) object to having restrictions in their areas; appropriately limiting those who can buy permits to the visitors and residents of the properties that have the parking restriction outside their properties. This would help prevent the problem commuter parking that affects us at number 6 and our immediate neighbours, without restricting parking to the rest of Allnutts Road where most residents need to park on the road/pavement as they have no off-street parking and seem somewhat reluctant to pay for a parking permit, as well as visitors to the Allnutts Institute and Shop.



The new policy on limiting parking permits to only two per property is also an issue that may cause increased objections from multi-vehicle families, preventing long awaited much needed schemes from being implemented. The proposed scheme also mentions unlimited visitor permits, please ensure this is not abused so that they cannot be sold on to commuters circumventing the parking restriction.

### Weekend Parking Problems in Allnutts Road

Weekend parking has also begun to increase recently with people parking to travel by train to shop at Westfield Stratford City and attend West Ham matches at the Olympic Park, to save having to pay higher parking charges there. The proposed parking restriction does not prevent any weekend parking and we would request that this be kept under review as when the Epping and Ongar Steam Railway is operating, the car park at Epping Station even at weekends does get full. Although it only costs £1.50-£2 to park at the station at weekends people will always try to park for free nearby even if there are spaces available, just to avoid paying. Please note that the Monday to Friday No Waiting restriction that was in place in Hillcrest Way has already been replaced with No waiting at anytime because it was overwhelmed by vehicles parking for free at weekends.

This year there will be increased pressure from people wishing to park to attend the Anniversary games in July and World Championship Athletics in August at the Olympic Park in Stratford, both of which will have events taking place at the weekend. During the 2012 Olympic games commuters, spectators and volunteers all parked vehicles causing traffic chaos in Allnutts Road and surrounding roads that had no parking restrictions, please don't let this happen again!

In short please implement some much needed parking restrictions to our part of Allnutts Road as soon as possible.

Dear Mr. Walker,



In response to your notice dated 9<sup>th</sup> March 2017 regarding the aforementioned introduction of Permit Holder parking and No Waiting restrictions in Zone EF1 of the Epping Forest District, we are writing to express support for the order as proposed in full.

The on-street parking situation in this area of Epping over the past ten years has greatly deteriorated due to a significant increase in commuter parking by users of Epping London Underground station. This has been exacerbated by the introduction of parking restrictions elsewhere within Epping which has resulted in our streets being the nearest unrestricted street parking to the station, and well within reasonable walking distance.

As you are probably aware the car park at the station is not adequate to cope with the demand from commuters, and NCPs pricing gives them ample incentive to street park and walk the short distance. Added to this the high commuters from a much wider catchment than would normally be planned for.

This is a perfect storm, and there are daily examples of dangerous and obstructive parking in our street, and we know that other adjacent streets with less space for driveways suffer even more greatly. Commuters arrive from 6 am and do not disperse until past 7pm. Cars park on corners, smart cars park perpendicular on the pavements, and driveways are obstructed. Understandably this has led some residents to feel that they have to take matters into their own hands to reserve spaces for their own cars by placing bins, road cones and even painting their own white lines to try and deter commuters, and there have been confrontations.

This situation must be regularised and brought under control for the good of the community urgently. Whilst we understand that there are some residents (including some with more than one car) who resent the idea of having to pay for permit parking, we feel that it is for the greater good that the proposed restrictions be implemented. Many residents on our road will not be liable to a charge as they have an off street driveway and will benefit from it not be being blocked by commuters, and those that have not paid for driveway installation would hopefully recognise the

benefit of the payment to guarantee them their space. We have checked your website and think the arrangements for daytime visitor parking, whilst perhaps being judged to be a 'new bureaucracy' by some, are relatively straightforward and people will get used to them. All permutations that people have used against the scheme previously seem to be catered for.

Therefore we would like to strongly support the proposals in your notice, and hope that you are able to implement them as soon as possible.

Hello

I live in Brook Road Epping CM16 7BT and am contacting you today to voice my SUPPORT for proposed parking restrictions in my road and the surrounding roads in Epping,

Parking is a real problem in Brook Road. Residents largely respect each other's space and muddle by to 'make it work'. However, as one of the few roads on the south side of Epping without resident parking restrictions, a large volume of commuters park in our road every day. There is not room for all of us. I appreciate that as a resident I don't 'own the road'. As frustrating as it is not being able to park in my road (and I mean 'road', not 'outside my house' here. I have often had to drive in to another street - particularly problematic for my husband after a long night shift as a Met Police officer who just wants to get in to bed), the main problem is how commuter parking exacerbates traffic problems in the narrow road. More parked cars = fewer places to give way to other vehicles. Fewer places to give way = more shouting and horn blaring. A large volume of parked vehicles considerably reduces visibility creating additional danger - something I personally experienced last August when a vehicle pulled off a drive in Brook Road and, not being able to see around the snake of parked cars, reversed straight into my path. Luckily I was moving fairly slowly. Luckily it 'only' cost £500 to fix. Luckily (and most importantly), the toddler strapped in to the back seat was unharmed. Could have been pretty nasty though.

I recently had to park on the drive of a neighbour I had never met before some way down the road (she kindly offered when she saw me driving around aimlessly. Good way to meet your neighbours at least I suppose!) as there was literally nowhere else to leave my car in the road or any of the surrounding roads. I was considering driving to the high road, paying to park and then walking back to my house - ludicrous!

I fully support planned restrictions. I was surprised to learn that resident's will have to pay for the first permit, however am prepared to accept that in order to park near my property.

Further to the consultation papers that I received last month and a follow up letter from Jon Whitehouse, I am writing to confirm my full support for this scheme. As a resident of Allnutts Road, I have been plagued since moving here 3 years ago with commuters using our road to park on all day whilst they walk to Epping tube station. There are times when we are unable to come out of our car park spacw and turn onto the road because cars are parked almost covering our entrance. I have witnessed my neighbours who sometimes are unable to get off their own driveways or having to manoeuvre in such a way that they have to go in the opposite direction that they require, just to get out of their driveway.

I have also witnessed a neighbour who ordered fresh cement to pour their driveway, but the lorry could not get up the road and they were unable to pour the concrete, which must be used immediately. They main other issue is the bin lorries who struggle each week to get through parked cars and the residents suffer firstly by sometimes not having their bins emptied and the whole process seems to take an hour sometimes, as they try to get through small gaps as cars are parked on both sides of the road. As these people who park and go all day, there is no one to contact when their car alarms get activated and we have to listen to the noise all day.

Finally, the most disturbing problem is lack of access for emergency services and there are days when I know that a fire engine or ambulance would not fit up the road and the result of this is quite frightening.

Therefore this decision has my full backing and support and I would imagine that the reason there were only 15 replies were that there will be very little opposition to this proposal from the residents of Allnutts Road.

I also want to point out that I was not aware of the need for me to respond with my views as I have not received any correspondence with these instructions. I received a letter from Councillor Jon Whitehouse this evening explained that we have until tonight to respond with our views.

I have spoken to several neighbours who have also not received any letters and I'm concerned that this could turn the decision against the residents who are in support.

The aforementioned roads are literally at breaking point and residents are now becoming desperate. Especially residents with children like myself. The main reasons for my support are:

- -Our roads are congested with commuters fighting for spaces from 7am and they do not return until the evening.
- -Cars are sometimes parked here for weeks when their owners go on holiday.
- -Dustcarts cannot access our roads sometimes due to cars parked on bends.
- -Pedestrians are at risk due to limited visibility when crossing roads.
- I sometimes have to park on double yellow lines to take my sleeping toddlers out of the car and have received tickets in the past.















This is to confirm I fully support the parking restrictions proposal that have been suggested.

Allnutts Rd is constantly full of cars Monday to Friday from 6am until 7pm. The pavements are impossible to walk down and this week for example I have had a car parked outside my house for 4 days continuously.


I am having building work carried out and have been unable to order a skip until it moved!
