

Old Ipswich Road-Ardieigh

The introduction of a red route restriction opposite the junction leading to Turnpike Close and the entrance to the Ardleigh car boot and aggregates site, where none currently exist will serve to prevent parking and improve access, providing improved lines of sight on exiting, benefiting all road users but particularly larger vehicles such as HGVs. A new residential development close to the junction will lead to additional vehicular movements, as well as increased traffic resulting from the potential development of the aggregates site.

The removal of some parking currently experienced on the highway running beneath the A12 will provide motorists with passing places where none currently exist.






