
#### Statement of Reasons.

#### Wrights Green Lane-Little Hallingbury

The order is required to keep the frontage of the school free of parked vehicles where any parking is considered to be a hindrance to access & pupil safety. Removing parked vehicles will also improve safety and reduce the probability of road traffic accidents and promote access to larger vehicles, particularly the school bus which will benefit from its own parking space.

#### **Chapel Hill-Stansted**

A change to the current permit parking operation times is intended to improve the parking provision available to residents and their visitors in the road and to prevent access issues regularly encountered. The road is within a short walking distance of the train station and non-residents often park in areas inappropriately, outside of the current permit restriction times, causing inconvenience to road users and local property owners.






