The effect of the Order: To revoke existing restrictions on Balkerne Gardens, Balkerne Gate and Balkerne Passage; to introduce 'Restricted Zone (No Waiting At Any Time and No Loading 10am-11pm)' on Balkerne Gardens, Balkerne Gate and Balkerne Passage for their entire lengths; to introduce 'Bus and Coach Parking Only' bay on Balkerne Gardens and to introduce 'Loading only' bays on Balkerne Gardens and Balkerne Gate in the Borough of Colchester.

This Order will be incorporated into The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by replacing tile number TL990 250 with revision 2.

Date of operation: The Order will come into operation on 9th May 2022




