## **Statement of Reasons**

The amendment is required to vary the provisions of the existing The Essex County Council (Epping Forest District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 and subsequent amendments by making administrative changes due to the implementation of The Traffic Management Act 2004 Part 6. The Order replaces provisions relating The Civil Enforcement of Parking Contraventions (England) General Regulations 2007 and introduces provisions relating to the Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022.
