The effect of the Order: To introduce 'Waiting restrictions' on Elmbridge in the district of Harlow.

4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by regulations made or having effect as if made under the Act or by any other enactment.

Statement of Reasons

Elmbridge/Hobbs Cross Road – Harlow

The permanent order for the extension of junction protection is required to keep the road free of parked vehicles where it is considered that any parking is inappropriate.

Permanent Orders Section 1(1) of the 1984 Act states that local traffic authorities in England and Wales (outside London)² may make permanent orders for the following purposes:

To facilitate the passage on the road or any other road of any class of traffic (including pedestrians);

To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising;

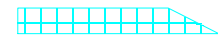

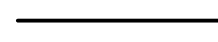


