

The Essex County Council (Braintree District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.44) Order 202x

Notice is hereby given Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1st July 2022 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

The effect of the Order:

1. To introduce No Waiting at Any Time restriction on the North side of Colchester Road, Halstead in a westerly direction from its junction with McDowell Mews for approximately 15.6 metres to adjoin existing No Waiting at Any Time restrictions (across the entrance to the cemetery).
2. To introduce No Waiting Monday to Friday 8am to 7pm on the North side of Colchester Road, Halstead between existing No Waiting at Any Time at the entrance to the cemetery for approximately 87.85 metres in a westerly direction to adjoin the existing No Waiting at Any Time restriction.

This Order will be incorporated into The Essex County Council (Braintree District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by replacing tile numbers TL815 305 revision 0 replaced by TL815 305 revision 1.

Statement of Reasons

Colchester Road, Halstead

To introduce No Waiting at Any Time restriction on the North side of Colchester Road, Halstead in a westerly direction from its junction with McDowell Mews for approximately 15.6 metres (across the entrance to the cemetery).

To introduce No Waiting Monday to Friday 8am to 7pm on the North side of Colchester Road, Halstead between existing No Waiting at Any Time at the entrance to the cemetery for approximately 87.85 metres in a westerly direction to adjoin the existing No Waiting at Any Time restriction.

- Currently cars park part on/part off the footway creating accessibility issues for many pedestrians. This is especially problematic for those who are less mobile, disabled and/or mobility impaired. The residual available footway width is insufficient for persons with wheelchairs, or those pushing buggies to pass, without walking into the road and/or crossing the road.
- As the road is a busy through route, it is not considered reasonable for persons to have to cross the road at locations where there are no crossing points and there are poor sight lines - it is currently the situation that some users have little option but to walk between parked cars to cross the road. This is especially an issue for children.
- There is a pinch point on the southern footway where it passes the Baptist Church. Wheelchairs and buggies or persons walking with children are unable to navigate this safely.
- There are times when parking on both sides of the road coupled with the volume of traffic results in buses, HGVs and emergency vehicles having difficulty passing, particularly between the cemetery and Pretoria Road. This can lead to localised congestion particularly during the busy extended peak periods.
- The difficulties experienced in passing through the area lead to unreliable journey times for the local bus services on which many residents rely.
- To minimise the level of disruption to residents the parking restrictions are planned to only be in operation during the most problematic part of the day.

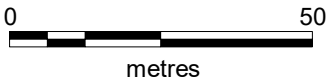
WHEREAS Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1st July 2022 in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The Essex County Council (Braintree District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.44) Order 202* and shall come into operation on XX XX XX.
2. This Order will be incorporated into The Essex County Council (Braintree District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 ‘the 2019 Order’ by:
 - a. replacing the following Map Tile:

TL815 305 revision 0 to TL815 305 revision 1
3. The Map Schedule Legend to this Order only applies to the Map Tiles listed in this Order.
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by regulations made or having effect as if made under the Act or by any other enactment.
