## Statement of Reasons

## **Bemerton Gardens, Kirby Cross**

To introduce No Waiting At Any Time in Bemerton Gardens (West entrance) from its junction with the B1033 Kirby road for approximately 25m south on both east and west sides of the road.

The recent opening of a Tesco Express store at the junction has increased the number of vehicles parking near to the junction of Bemerton Gardens and Kirby road (B1033).

The store has an off-street free car park for customers.

The introduction of No Waiting at Any Time on both East and West sides of Bemerton Gardens near to its junction with B1033 is considered necessary to prevent short term parking near to the road junction and reducing sight lines as well as narrowing the road requiring vehicles to move onto the opposite carriageway to pass static vehicles.

- To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising;
- To facilitate the passage on the road or any other road of any class of traffic (including pedestrians);
  - To preserve or improve the amenities of the area through which the road runs.


